4. PROTECTION INFORMATION

Respiratory Protection: None generally required, Avoid casual breathing of vapors

5. HEALTH HAZARD INFORMATION

Inhalation: Remove to fresh air. Give oxygen if breathing is labored and seek medical advice. Avoid casual breathing. Signs of over exposure are dizziness

and nausea.

Skin Contact: Skin contact can produce irritation, or itching of the skin. Remove contaminated clothing Wash with soap and plenty of water. Seek medical attention if irritation persists.

Eye Contact : Contact with eyes can produce burning sensation. Irrigate with water immediately, continue flushing eyes with water for 15 minutes. Seek medical attention if irritation persists.

Ingestion: Rinse mouth; dilute with milk or water and consult a physician immediately. Do not induce vomiting. Never-give anything by mouth if victim is unconscious, is rapidly losing or is Convulsing

7. HANDLING AND STORAGE

Handling: Follow good industrial practice as to housekeeping, Avoid inhalation, contact with skin and eyes. Wear splash goggles and oil-resistant gloves. Provide good ventilation.

Storage: Containers should be kept closed in order to minimize contamination. Store in a cool, dry, well ventilated place protected from light. Keep away from extreme heat and from freezing conditions and away from all sources of ignition
